ENROLLMENT AGREEMENT

1. I give permission for the camper to attend Camp Kiowa, L.L.C. (hereinafter referred to as "Camp Kiowa") during the 2012 camp season and to participate in all activities sponsored by Camp Kiowa, on or off camp premises, whether or not identified in the camp brochure. This includes but is not limited to rock climbing, ropes course, water park, use of cooking utensils and equipment in cooking class, and travel in camp-provided or other motor vehicles. I understand that there are risks of bodily injury in these and other activities that are conducted at Camp Kiowa. I hereby release and hereby indemnify from liability (that is, hold harmless in all respects) the camp owners, directors, counselor staff and all other employees and agents of Camp Kiowa, with regard to all claims for liability resulting from injuries that may be incurred as a result of the camper's participation in all camp activities.

2. Requests to change the weeks of attendance or lengthen a camper's stay can be made only if space is available, as determined entirely at the discretion of Camp Kiowa.

3. No refund shall be made for a camper arriving late, leaving early or missing any portion or all of the camp session, irrespective of cause.

4. Camp Kiowa reserves the right to dismiss a camper whose conduct or influence is unsatisfactory or detrimental to the best interests of the camp, as determined entirely at the discretion of Camp Kiowa. No refund shall be made for any portion of the camp session not attended by a camper because of dismissal.

5. Camp Kiowa recommends that no valuable items, such as expensive watches, rings, cameras or jewelry be brought to camp. Camp Kiowa is not responsible for any lost or damaged property of any kind, including, without limitation, clothing, electronic equipment, sports equipment, games, audio equipment and music collections, cash and personal possessions. Camp Kiowa is responsible for a camper's airline ticket and cash if they are deposited directly with the camp office.

6. Camp Kiowa is authorized, during the camp session, to make all decisions concerning the camper's emergency health and safety needs, including, but not limited to, firstaid and emergency medical treatment of the camper (including, without limitation, hospitalization and surgery.) I fully release Camp Kiowa and its authorized representatives from any liability for any such actions. Payment for all medical and related expenses are my responsibility, not Camp Kiowa's. If the medical provider does not accept my medical insurance, then I shall pay the medical provider. I shall reimburse Camp Kiowa upon receipt of written invoice for any such expense paid by Camp Kiowa, and any such payment by them shall be an advancement against such reimbursement.

7. The camper will not be allowed to attend Camp Kiowa without providing Camp Kiowa with a fully completed medical form that includes the camper's health history and is signed by the camper's parent or guardian and the camper's physician. The medical form must be satisfactory to Camp Kiowa in form and substance, as determined at Camp Kiowa's sole discretion. The medical form must be completed within three months of camp attendance and provide evidence that the camper has been medically examined within twelve months of camp attendance.

8. I consent to the reproduction and use of the camper's photograph, audio recording, video image or other likeness of the camper for the purpose of promoting or advertising Camp Kiowa and for other camp-related purposes.

9. Camp Kiowa policy prohibits a camper being taken from camp without prior authorization from a Camp Director.

10. I agree that this Agreement shall be construed and enforced under the laws of Texas. The venue for any legal dispute with Camp Kiowa arising under this Agreement or from the camper's attendance of Camp Kiowa shall be Denton County, Texas.

FEES

1. A \$250 deposit is due with this Enrollment Agreement.

2. All tuition fees must be paid in full by June 1, 2012. Camp Kiowa reserves the right not to admit any camper if all tuition fees are not paid in full by June 1, 2012.

3. There is a \$25 charge for any returned checks.

4. Fees are 100% refundable on or before 02/01/12.

Fees are 75% refundable on or before 03/01/12.

Fees are 50% refundable on or before 04/01/12.

Fees are 25% refundable on or before 05/01/12.

Fees are nonrefundable after 05/02/12.
